

AGREEMENT

Student's participation in the classes is at their own discretion, and he/she may choose to cease participation at any time. The seventy-five dollar (\$75) registration fee and the regular class fee of ten dollars (\$10) is due on the student's first day of participation for the year, bringing the total due to eighty-five (\$85). Returning students agree to pay the annual registration fee (at the beginning of each January) of twenty-five dollars (\$25) in cash or check, in one installment, and then each week that he/she chooses to attend, the cash total of ten or twenty dollars (\$10 or \$20) in one installment, and accept instruction in the martial arts and self defense. Classes are held at the SOILMMA Dojo located at 504 DD Road in Columbia, Illinois on Monday's and Thursday's. The seventy-five (\$75) and twenty-five dollar (\$25) new and annual registration fee and ten dollar (\$10) class fee is not refundable under any circumstance after the first class of any session. New (first time) students will be given a plain black martial arts uniform consisting of jacket, pants, white belt, school patch, and knee pads by the (3rd) third class of the current session.

Additional martial arts uniforms and equipment is available for purchase before classes begin. All uniform and equipment sales are final (no refunds) and the price includes applicable sales tax. Additional jackets, pants, or belts may be purchased if the student has sizing issues. (No exchanges). Karate classes consist of sixty (60) minutes of training each. Jujitsu class consists of one hundred twenty (120) minutes of training each. Discounts apply for Karate students who train in Jujitsu classes.

Rank advancement is available, and will be offered near the end of each session. Advancement is not required, but if the student wishes to test for higher rank, the test fee for promotions to yellow, orange and green belt (novice student) is fifteen dollars (\$15); blue and purple belt (intermediate student) is twenty dollars (\$20); brown belt (senior student) is twenty-five dollars (\$25); black belt (assistant instructor) is one hundred (\$100). All belt fees are to be paid on the day of the examination for rank advancement. This is in addition to the regular class fee of ten or twenty (\$10 or \$20) dollars. This test fee will include a belt that will be presented to the student if their performance merits promotion to a higher rank. In the event that the student's performance does not merit promotion to a higher rank, the test fee will be refunded but not the class fee. Students must be dressed out and participate in the class when new belts are presented. Belts and other awards will not be given to those who do not participate in class. Students must attend 100% of the classes offered for promotion consideration at the end of each session. If the student misses a class, make up classes are available at the normal class rates.

Students agree to refrain from wearing jewelry, chewing gum, wearing their nails (both on hands and feet) long enough that there may be a danger of injury to the student or to fellow students. The proper length will be determined by the instructor, but generally the proper length is one that makes it difficult to cut or stab or otherwise injure oneself or others. Safety of the students is always the primary goal.

Students and observers agree to conduct themselves with attentiveness, courtesy, and respect, toward both instructors and others. Improper or disruptive behavior in the form of attitude or actions is unacceptable and will be cause for being banned from further attendance at classes. As with many school districts, we have adopted a "Zero Tolerance" policy with regard to this type of behavior from both students and observers. Observers must remain in designated areas and keep voices and distractions to a level in which does not interfere with class instruction.

RELEASE OF LIABILITY

I hereby acknowledge that participation in this training is strictly to raise awareness and to provide knowledge of martial arts and self defense. I have read and understand the disclaimer and agreement

above. I hereby waive, release, and discharge the Southern Illinois Martial Arts organization, any and all rented or leased facilities for training purposes, Tom Belt, his heirs, representatives, assigns, and all persons who may be liable on their behalf, of any and all liability for actions, causes of actions, claims, demands, and damages of whatever name or nature, which may in any manner arise in relation to this training and my using the information obtained in the training.

I further agree to indemnify the Southern Illinois Martial Arts organization, any and all rented or leased facilities for training purposes, Tom Belt, his heirs, representatives, assigns, and all persons who may be

liable on their behalf, of any and all liability, both personal and property, which I may incur by using information obtained in the training, thereby causing injury or damage to persons or property. This indemnification shall include the payment of reasonable attorney's fees in the defense of any such action.

I hereby declare that I am at least eighteen (18) years of age, and have relied upon my own judgment, belief, and knowledge of the instruction offered, and that no representation or statements about this Release of Liability, or Agreement, or Disclaimer have influenced me in making this Release.
